Students are expected to read and discuss this agreement with their parent/carer and then to sign confirming that they will follow the terms of the agreement. Any concerns or queries regarding this agreement should be directed to the College.

	I will only use ICT systems in College, including the internet, email, digital video, and
	mobile technologies for College educational purposes.
	I will not download, install or modify any software or change any configuration
	settings on any College technologies.
	I will only log on to the College network/ Learning Platform with my own user name
	and password.
	I will follow the College ICT security system, not revealing my passwords to anyone
	and changing them regularly.
	I will only use my College email address.
	I will make sure that all ICT communications with students, teachers or others are
	responsible and sensible.
	I will be responsible for my behaviour when using the internet. This includes the
	resources I access and the language I use.
	I understand that cyberbullying is unacceptable, and will not use technology to bully,
_	impersonate, harass, threaten, make fun of or upset anyone, at College or outside.
	I will not deliberately browse, download, upload or forward material that could be
	considered offensive or illegal. If I accidentally come across any such material I will
_	report it immediately to a member of staff.
	I will not give out any personal information such as name, phone number or address.
	I will not arrange to meet someone, unless this is part of a College project approved
_	by a member of staff.
	Images of students and/or staff will only be taken, stored and used for College
	purposes in line with College policy and not be distributed outside the College
	network.

	I will ensure that my online activity, either in or outside the College, does not cause the College, staff, students or others distress, or bring them into disrepute.  I will respect the privacy and ownership of others' work on-line at all times.  I will not attempt to bypass the internet filtering system.  I understand that my use of the internet and other related technologies can be monitored and logged, and can be made available to my teachers.  I understand that any devices issued to me remain the property of Crookhorn College and I will return the device before the end of the College day.
